

# Metallic Colour Coat

## Description

Factory-mixed, 100% acrylic polymer coating METALLIC COLOUR COAT imparts a unique pearlescent appearance.



## Primary uses

- To provide a unique metal panel appearance over surfaces prepared with Senergy® SKIM COAT in Senerflex®, Senergy Cement-Board Stucco™, all Senergy Surfacing Systems and interior veneer plaster or gypsum board applications.

- For graphic highlights or to change the color of any Senergy Wall System or other compatible EIFS Finish.
- For use as a coating over Senergy textured Finishes in all applications for which Senergy Finishes are approved; e.g. EIFS, stucco, Cement-Board Stucco, all Senergy Surfacing Systems, and poured concrete or unit masonry and interior veneer plaster or gypsum board applications

## Packaging

18.1kg per 19 litre pail

## Colours

Available in 5 standard color and custom colours.

## Coverage

Approximately 10.76m<sup>2</sup> for the first coat, 12.91m<sup>2</sup> for the second coat and 15.07m<sup>2</sup> if a third coat is requested. Varies depending upon texture of surface over which it is being applied.

# Metallic Colour Coat

## Mixing

- Mix the contents of the METALLIC COLOUR COAT unit with a low speed drill and paddle mixer until thoroughly blended.
- A small amount of clean, potable water may be added to adjust workability, but is generally unnecessary since a thick consistency is desired.
- Additives are not permitted.
- Close container when not in use.
- Clean tools with soap and water immediately after use.

## Application

### To replicate the appearance of a metal panel:

- Apply SKIM COAT over wall system to be covered with METALLIC COLOUR COAT according to Senergy SKIM COAT application procedures described in SKIM COAT Product Bulletin.
- When SKIM COAT application is completed to satisfactory surface flatness, surface must be clean, dry and free of contaminants. As required, rinse wall thoroughly with clean water and allow to dry.
- Apply the first coat of Senergy METALLIC COLOUR COAT using a 21,000–25,000 tip and airless spray equipment.
- The METALLIC Coating must be applied in multiple layers of thin coats, always keeping a wet edge. Multiple coats of METALLIC COLOUR COAT will be necessary.
- Repeat as necessary, using typical painting practices and protecting each coat from debris and precipitation while drying.

## Limitations

- Protect Senergy materials during transportation and installation to avoid physical damage.
- Store Senergy materials in a cool, dry place protected from freezing. Store at no less than 4°C Protect from extreme heat and direct sunlight. Shelf life is two years when unopened and stored as directed.
- Do not apply Senergy materials in ambient temperatures below 4°C Provide supplementary heat during installation and drying period (at least 24 hours after installation and until dry) when temperatures less than 4°C prevail.
- Protect work from precipitation until dry.
- Do not apply Senergy materials to frozen surfaces.

## Graphics/colour change:

- Cover surface to be coated with METALLIC COLOUR COAT with a layer of Senergy Base Coat and Reinforcing Mesh according to Senergy specifications and application procedures for the Base Coat.
- If METALLIC COLOUR COAT is used over a Senergy Finish, apply the finish according to specifications and application procedures for the Finish.
- Surface must be clean, dry and free of contaminants. As required, rinse wall thoroughly with clean water and allow to dry.
- Apply METALLIC COLOUR COAT with a 10 mm nap roller or airless spray equipment. If necessary, cut in the edges with a high-quality, latex-type paint brush.
- Brush or roll out in all directions, maintaining a wet edge at all times.

# Metallic Colour Coat

- METALLIC COLOUR COAT must be worked continuously until a uniform appearance is obtained over the entire wall surface.
- Allow the first coat to dry prior to application of the second coat.

## Preparation

The METALLIC COLOUR COAT must be strained with a paint strainer/filter prior to use in a spray application.
